Regular monitoring of dental/medical office sterilizers is essential to detect failures in the sterilization process and is an important step in infection control. With the increased awareness regarding the transmission of infectious diseases, it has become necessary to use sterile instruments to prevent cross infection.

Verifying the effectiveness of your sterilizer using biological indicators (spore strips) is the most approved method of sterilizer monitoring. Chemical indicators alone are not sufficient to confirm the adequacy of the sterilization cycle. The Centers for Disease Control (CDC), the American Dental Association (ADA), and the State Boards Dental Examiners of several states, including the State of Texas, recommend dental practitioners to document the effectiveness of sterilization devices with biological indicators on a weekly basis.

Texas A&M College of Dentistry has been monitoring sterilizers for more than 30 years and since 1988 we have also extended our services to private dental/medical practitioners. We are involved in the instructional and investigative levels of infection control in dentistry at our institution. As our customer, you will benefit from our experience in these areas.
