Planning

- 7.1 Determine priorities and establish oral health goals with the patient/family and/or guardian as an active participant.
- 7.2 Acknowledge cultural differences in populations when planning treatment.
- 7.3 Establish a planned sequence of educational and clinical services based on the dental hygiene diagnosis using the problem-based approach.
- 7.4 Communicate the plan for dental hygiene services to the dentist or other interdisciplinary health team members to determine its congruence with the overall plan for oral health care.

Implementation

- 8.1 Provide an environment conducive to health by using accepted infection control procedures.
- 8.2 Control pain and anxiety during treatment through the use of accepted clinical techniques and appropriate behavioral management strategies.
- 8.3 Select and administer the appropriate preventive and/or antimicrobial (chemotherapeutic) agents and provide preand post-treatment instructions.
- 8.4 Apply basic and advanced principles of instrumentation.
- 8.5 Provide dental hygiene services in a variety of settings.

Evaluation

- 9.1 Determine the clinical outcomes of dental hygiene interventions using indices, instruments, examination techniques, and determine the appropriate maintenance schedule.
- 9.3 Compare actual outcomes to expected outcomes when expected outcomes are not achieved and modify therapy as necessary.

Clinic/ Semester Requirements

Clinic I Requirements

To receive full credit, all of the following must be completed by 4:00 p.m. on Friday, May 9, 2025.

- Successfully complete comprehensive dental hygiene services on at least six (6) patients with a periodontal classification of Healthy, Gingivitis or Slight Periodontitis at the competent level.
 - Competence for 3830 patient care is defined as no more than one (1) score of 0 on the clinic evaluation sheet(s) in the categories of #1-#11and #13 and at least 3 of the 4 quadrants receive a minimum score of 1 for hard <u>and</u> soft deposit removal. Students must complete a minimum of 6 patients and obtain a 75% average to be passed to the next clinical course level; however, 10 percentage points will be lost for not completing the required amount of patients for the semester.
 - Half patient credit will count toward the patient load requirement if the patient is completed and 2 of the 4 quadrants are in the acceptable range for hard <u>and</u> soft deposit removal. The patient's dental hygiene treatment plan must be fully completed to recieve credit towards the patient requirement count.
- Successfully complete the Objective Structured Clinical Examination (OSCE) with a score of 75%. The OSCE will be administered in the dental hygiene clinic- see block schedule for planned OSCE day. OSCEs are very helpful in healthcare education because they allow students to practice and demonstrate clinical skills in a standardized healthcare scenario. Students can demonstrate competency in communication, history taking, physical examination, clinical reasoning, medical knowledge, and integration of these skills. It is meant to be a fair and accurate way to assess competence and identify areas that need more work and practice. During the clinical component, students will progress through stations where they will perform procedures and skills that they've learned and practiced during the semester. The OSCE is timed; if you arrive late, you will not receive a time extension. Information regarding OSCE stations, topics, and instructions will be given closer to the time of



the OSCE.OSCE stations may include but are not limited to: Safety and Infection Control, Medical emergencies, HHX review, Medication search, vital signs, EOIO, dental charting, gingival description, periodontal probing, periodontal assessment, instrumentation, treatment planning, axiUm navigation and documentation, polishing & fluoride, and power scaling.

- axiUm Training Modules- axiUm training assignments will be due throughout the semester based on new tasks learned during patient care. Students' H charts (same chart used from preclinic) will be used for these assignments. If you correctly complete the assignment with minimal errors, you will receive full points for the grade. All axiUm training modules must be successfully completed to pass the course.
- Maintain a competent level of safety and aseptic technique during patient care at all times. The following are the consequences for receiving a 0 in Aseptic Technique. The 0's are **cumulative** beginning with clinical course 3830:
 - <u>First offense</u> Discuss error with supervising clinic faculty at end of clinic session.
 - <u>Second offense</u> Same as first offense and meet with Clinic Coordinator within 48 hours of receiving error.
 - <u>Third offense</u> Same as second offense. In addition, one (1) percentage point will be deducted from final grade. Also, an infection control topic will be given and the student will be required to write a paper on the chosen topic.
 - <u>Four+ offenses</u> One (1) percentage point will be deducted from final grade for each offense and the student will be required to write a paper for each 0 received in aseptic technique. Topic(s) will be chosen by the clinic coordinator.
- Exhibit professionalism at an acceptable level as determined by the observing/supervising faculty. Unprofessional conduct subject to the Disciplinary Due Process Document will result in a permanent letter placed in the student's file and sent to Associate Dean of Student Affairs. Such infractions will be cumulative for the student's time here at the school.
 - After the first occurrence, the student will meet with the supervising faculty and Clinical Coordinator.
 - At the second occurrence, the student will meet with the supervising faculty, Clinic Coordinator and Program Director. In addition, ten (10) points will be deducted from the final course grade.
 - At the third occurrence, the student will meet with the supervising faculty, Clinic Coordinator, Program Director & Associate Dean of Student Affairs. In addition, the student will receive an "F" for the final course grade. Any unprofessional conduct may be subject to the College's due process procedures set forth in the "Texas A&M College of Dentistry Disciplinary Due Process Document" can be found at TAMU Academic Due Process Document
- Complete Mid and Final Advising Forms to an acceptable level. Points are deducted from final course grade for unpreparedness, incomplete paperwork, incomplete chart audits, incomplete documentation in axiUm and teams, and lack of communication and follow-through with Ms. Lisa or patients, evidence of mismanaging patient's or care of patients. (1-20+ points may be deducted)

Course Requirements

Assignments:

There will be several assignments assigned during your time in this course. These assignments are intended to enhance and assess your understanding of course content throughout the semester and provide practice opportunities to develop professionalism and clinical skills. **Therefore, completion of assignments are required for successful completion of the course.**

Clinical "Semester" Course Requirements:

To receive full credit, all of the following must be completed by <u>4:00 p.m. on Monday, May 5, 2025.</u>

- Successfully complete comprehensive dental hygiene services on at least six (6) patients with a focus on treating patients with a periodontal classification of Healthy, Gingivitis at the competent level.
 - Competence for 3830 patient care is defined as no more than one (1) score of 0 on the clinic evaluation sheet(s) in the categories of #1-#11and #13 and at least 3 of the 4 quadrants receive a minimum score of 1 for hard <u>and</u> soft deposit removal. Students must complete a minimum of 6 patients and obtain a 75% average to be passed to the next clinical course level; however, 10 percentage points will be lost for not completing the required amount of patients for the semester.
 - Half patient credit will count toward the patient load requirement if the patient is completed and 2 of the 4 quadrants are in the acceptable range for hard <u>and</u> soft deposit removal. Other Pertinent Course Information

Attendance Policy:

Attendance and punctuality is expected and required. Punctuality means that you arrive for class on time and that you are prepared to begin scheduled activities for the class session on time. Failure to meet this requirement will result in the student being marked tardy.



Clinic- If you are absent or will be late to a clinic session, please notify Ms. Lisa Pradarits (<u>lpradarits@tamu.edu</u>) and your Clinic Coordinator(CC) (<u>bcowen@tamu.edu</u>) of your absence or tardiness ASAP or prior to 8AM or ASAP. It will be up to the discretion of the CC if the tardy or absence is considered excused or unexcused. Make up clinic sessions are not guaranteed due to scheduling issues and available faculty.

Texas A&M University views class attendance as an individual student responsibility. Regular and punctual attendance is **mandatory** for scheduled or rescheduled classes, clinics, labs and related activities/events. The clinical faculty will take attendance at each session. Students who are not present at that time will be marked absent. Excessive absences (excused or unexcused) may result in an "F" for the course due to the lack of time in clinic to meet clinical requirements of the course. However, for any absences (excused or unexcused), it will be the student's responsibility to contact the Clinic Coordinator to discuss the student's plan of action for remain on track with clinical requirements for the semester.

Unexcused absences: Tardiness and non-emergent appointments (illnesses not considered <u>severe</u> or <u>contagious</u>) scheduled during clinic, rotation, and/or class time will be considered an unexcused absence. This may result in a loss of scheduled clinic time during the next semester in order to make up the rotation. All absences and tardies <u>must</u> be reported by <u>phone and email</u> to Lisa Pradarits at 214-828-8421 and the clinic coordinator and <u>must be received by 8:00</u> <u>AM</u> or earlier if possible so your patient or the rotation supervisor can be notified. You MUST leave a voicemail if they don't answer. Failure to do this may be reflected in your clinical grade under Clinical Conduct or Professionalism at the discretion of the Clinic Coordinator.

- <u>Each</u> unexcused absence will result in a four (4) point deduction from the final grade for each missed clinical session.
- Two (2) tardies are equivalent to one (1) unexcused absence= 4 pt deduction from final grade.
- Unexcused absences without notice may result in written documentation for unprofessional behavior as well as applicable point deduction.
- Three (3) unexcused absences will include all of the above as well as possible failure of the course.

Excused absences: It is understood that absences due to severe or contagious illness, injuries or emergencies may occur. An absence due to illness may require a medical confirmation note from a student's medical provider. For injuries or illnesses that require a student to be absent from class for three or more business days, a note from his or her medical provider is mandatory. If a student has frequent sick days, the program director may require a medical provider's note for each absence.

Religious holy day: A student whose absence is excused under or the observance of a religious holy day will be allowed to take an examination or complete an assignment from which the student is excused within 3 days after the absence. If the student fails to schedule and complete the exam or assignment within three days, a grade of zero will be given. Make-up sessions must be completed within **one** week of the excused absence. Late assignments due to an excused absence will be accepted with no point deduction, however, if you turn in assignments after the assigned "make up" due date, the assignment is considered late, and 10 points will be deducted from the assignment grade for each day it's late.

Rotations

Internal and external rotations are used to enhance and expand your clinical learning experience. It's required to attend all rotations and conduct yourself professionally: punctual, respectful, and intentional with your time. External rotations will complete an evaluation form on you by scanning a QR code on the back of your badge. This document will also serve as your attendance on the rotation. It is your responsibility to ensure the supervising faculty scans your QR code and completes the evaluation. Issues with tardiness and unprofessionalism will result in points deducted from your final course grade. You will be required to complete a self reflection of your external rotations to provide insight to your rotation experience and it's impact on you as a health care provider. Self Reflections are due the Sunday following your rotations by 11:59 pm.

No patient sessions:

Attendance is required at all assigned clinical sessions as if in private practice, regardless if your patient shows or not. If the student does not have a patient for the session, they are required to participate in a clinical activity approved by their supervising clinical faculty.



The student is required to have a patient for *every* clinic session. You get three (3) "freebie" no-patient sessions which are used on pt no-shows, cancels short notice, not able to find a patient, missed clinic sessions from absences) before it starts affecting your final grade, however, you still must stay for the entire clinic session and assist in clinical activities approved by your supervising faculty. Additional no-patient sessions will result in two (2) points deducted from your final grade for not having a patient in your chair (per occurrence.) An additional 2 point deduction may also happen if other poor scheduling decisions are made by the student, especially if they affect a patient in a negative way.

Mid-Semester & Final Advising/Professional Conduct:

At the end of each semester, the student will meet with the Clinic Coordinator for Final Advising to ensure all requirements are completed and all patients assigned to the student are accounted for. Students are expected to come organized and well-prepared. This meeting is scheduled during the week after Spring Break and Finals Week. All students are expected to participate and meet in-person. Vacations, travel, etc. are not valid reasons to miss the meeting. Meetings will not be rescheduled unless it is for an excused absence.

Two (2) points EACH will be deducted if any of the following occur during mid or final advising:

- The student arrives after their appointed time/ shows up late to clinic.
- The student runs over their assigned appointment time/ poor time management.
- The student has to return at another time or day to complete their Final Advising session.
- The student has more than 4 patients "in progress." This will be evaluated on a case-by-case basis.
 - If it is found that any of the patients left "in progress" were not completed in a timely manner due to the student's inability to schedule properly, a letter for Unprofessional Conduct may also be written and put in the student's record. Please read the section under "Clinic Policies and Procedures" regarding professional maturity for further explanation.
- Patients "in progress" from the previous semester have not been completed and/or accounted for.
- "Completed Patient Report" is inaccurate.
- Grades for each patient have not been entered into teams accurately for all completed patients.
- One or more patients "in progress" do not appear on the Request/Active Report.

NOTE: This list is not all-inclusive; it is up to the discretion of the Course Director to determine if other behaviors are deemed inappropriate or unprofessional and will also result in a <u>two-point deduction</u> to the final grade.

Late Work Policy

- Any work submitted after the assigned due date will receive <u>10 points off for each day</u> it's not turned in.
- Make up work for an excused absence is not considered late work, however, if the make up work is submitted after the make up assignment due date, 10 points will be deducted for each day it's not turned in.
- Regardless of lateness, all course assignments must be completed prior to the last week of the semester in order to pass the course. You will receive an incomplete grade in you do not complete all assignments for the course.
- IMPORTANT: Failure to remediate and repeat a score of <75% exams or make up assignments for all absences (excused or unexcused) by May 9, 2025 may result in an "F" for the course.

Course (Class/Lab/Clinic) Policies and Procedures

Attendance/Punctuality

Attendance and punctuality are professional expectations of all dental hygiene students. Attendance will be tracked in clinicand on all rotations. Remember, students who have unexcused absences and tardiness in clinic, labs, or rotations will result in two points off your final grade with each occurrence and you will not be compensated with additional clinic/class time or instruction as well as be subjected to <u>Texas A&M Student Rule 7.1</u>. More than 15 minutes late for class will result in an unexcused absence



Excused absences: It is understood that absences due to severe or contagious illness, injuries or emergencies may occur. An absence due to illness may require a medical confirmation note from a student's medical provider. For injuries or illnesses that require a student to be absent from class for three or more business days, a note from his or her medical provider is mandatory. If a student has frequent sick days, the OSA may require a medical provider's note for each absence. **Note:** An absence for a non-acute medical service does not constitute an excused absence. **Religious holy day:** A student whose absence is excused under or the observance of a religious holy day will be allowed to take an examination or complete an assignment from which the student is excused within 3 days after the absence. **If the student fails to schedule and complete the exam or assignment within three days, a grade of zero will be given.** Make-up exams, assignments and observations must be completed within **one** week of the excused absence. Late assignments due to an excused absence will be accepted with no point deduction; however, if you turn in assignments after the assigned "make up" due date, the assignment is considered late and 10 points will be deducted for each day it's late.

<u>Unexcused absences:</u> Tardiness and non-emergent appointments (illnesses not considered <u>severe</u> or <u>contagious</u>) scheduled during class time will be considered an unexcused absence. Students who have unexcused absences and tardiness in class, lab, clinic, or senior observations will result in <u>two points off your final grade with each occurrence</u> and you will not be compensated with additional clinic/class time or instruction. If a student misses a senior observation, the student will be required to make-up the observation time at the discretion of the course director. For an unexcused absence on the day of an exam, the student must contact the course director to schedule a time to remediate the exam and must schedule to take the make-up test proving 75% competency within two weeks, but the student will receive a "0" for that exam. Examinations <u>will not</u> be administered in advance for a planned/anticipated unexcused absence.

<u>For any absences:</u> (excused or unexcused), it will be the student's responsibility to review the lecture recordings for the class(es) missed. Additionally, the student must complete a make-up assignment(s) within one week after returning to school. The make-up assignment will require the student to thoroughly answer the learning objectives (written by hand) for the class session(s) missed and any other assignments missed during the absence.

Dress Code

Clinic Sessions

Appropriate <u>clinic dress code is required at all times for clinic and all rotations.</u> Follow the block schedule and communicate when you are confused. Check messages/ announcements daily in Canvas, axiUm, and MS Teams to ensure you are aware of any changes for the week. Borrowing another student's badge to check items out of the dispensary, login to axiUm, or to get into the clinic is prohibited! Failure to bring your badge or follow the protocol of gaining new badge from HR will result in points deducted in professionalism. Practice time in the clinic is precious, and we don't have time to make up missed sessions, therefore, every attempt should be made to effectively use <u>all</u> your scheduled clinic time, regardless if you have a patient or not. Not efficiently utilizing your clinic time will result in points off your clinical conduct grade and may result in deduction in professionalism points. Independent practice outside of normally scheduled class time is strongly encouraged and often necessary to meet the requirements of this course.

Remediation Policy

Remediation will take place in the following semester and will put the student one semester behind for graduation. <u>A</u> <u>grade of 75 or "C" is the minimum acceptable grade on OSCEs.</u> If any exam grade is below 75, you will be required to meet with the course director to pursue additional study and remediation session reviewing your evaluation/examination. This is so you can demonstrate an adequate level of knowledge of the material before moving to the following semester. Your academic advisor and the Office of Student Development will be informed, as it may also be recommended that you meet with an educational specialist to review study habits, note taking and test taking strategies.



Classroom Cell Phone Policy: The full attention of each student is expected and required for the successful completion of this course. Electronic devices used in class for non-learning purposes can be distracting and may hinder learning. Please store cell phones in your backpack or locker, unless using for educational purposes (must be approved by the course director). Students will be asked to put away such devices OR to leave the classroom if the devices become distracting to faculty or other students. If a student is caught on their electronic device or cell phone during class time, this may be counted as an unexcused absence. Point deduction to the final course grade will be applicable in these instances.

Preparation: Read, review, and complete all assignments or instructions prior your scheduled clinic sessions. Not having all required supplies and/or materials necessary for each class/clinic session displays a lack of preparation for class. It is the student's responsibility to bring all items listed on the course outline.

Professional Written Communication (emails/assignments): Effective written communication affects all aspects of your professional career, including your ability to successfully connect with your patients and colleagues, therefore, spelling and grammatical accuracy are critical skills for dental hygiene practice. All written communication in this course will be presented in a professional tone with the content of the message presented clearly and in an organized manner. Communicating professionally in writing requires the writer to ensure that the message is free of spelling, grammatical and sentence structure errors. A professional tone is one that is free of jargon, informal abbreviations and emotion. In addition, professional written communication in this course which does not meet these criteria shows unprofessional behavior and can affect your overall course grade. You may use the TAMU Writing Center or grammarly.com if a student continually struggles with their writing skills for the emails and course assignments.

Announcements: Announcements posted on Canvas will be e-mailed to all students (check your preferences.) Students are responsible for checking e-mail and Canvas 2x a day and to keep their mailbox clear to receive emails. If you use a personal e-mail versus your TAMU email, you are responsible for forwarding TAMU email to your personal email.

E-mail correspondence: Any message or email sent to the course director or other clinical instructors, must come from through the student's TAMU email, Canvas, or MS Teams. The course director will not reply to emails from a non-TAMU email address. In general, emails will be sent and returned during regular business hours (within 24-48 hours.)

Grading: It is the student's responsibility to check Canvas daily for announcements and current grade postings. Any questions regarding grades must be brought to the attention of the course director no later than two weeks after grades are posted.

Professional Behavior: Students must demonstrate professional behavior and communication at all times. If a student fails to demonstrate professional behavior during the course, a meeting with the course director may be required. Unprofessional behavior includes, but is not limited to, a breach in integrity, excessive tardiness and absenteeism, unnecessary talking, loud talking/laughing, inappropriate language, or participating in any activities that do not directly relate to the course, disruptive and/or unprofessional behavior, failure to fully engage, failure to prepare for class, inappropriate handling of electronic devices, cheating, lying, and collusion, disrespect to peers, staff, faculty and refusal or lacking ability to follow all ethics, policies, and/or procedures. Unprofessional behavior or communication in clinic will be documented and addressed immediately. Unprofessional conduct subject to the Disciplinary Due Process Document will result in a permanent letter placed in the student's file and sent to Associate Dean of Student Affairs. Such infractions will be cumulative for the student's time here at the school.



- After the first occurrence, the student will meet with the supervising faculty and Clinical Coordinator.
- At the second occurrence, the student will meet with the supervising faculty, Clinic Coordinator and Program Director. In addition, ten (10) points will be deducted from the final course grade.
- At the third occurrence, the student will meet with the supervising faculty, Clinic Coordinator, Program Director & Associate Dean of Student Affairs. In addition, the student will receive an "F" for the final course grade. Any unprofessional conduct may be subject to the College's due process procedures set forth in the "Texas A&M College of Dentistry Disciplinary Due Process Document" can be found at <u>TAMU Academic Due Process</u>

Student Roles & Responsibilities:

- 1. <u>Be present:</u> Attend all classes/clinics on time as scheduled and be intentional in all aspects of the learning process.
- 2. <u>Be prepared:</u> Prepare for class/clinic by completing all assignments denoted on the course outline, bringing all required supplies, and actively participating in the learning discussions/activities.
- 3. <u>Be aware:</u> Contact the course instructor to make up missed assignments/clinics and for extra help as needed. It's the student's responsibility to self-reflect and to become self-aware of their learning and current skills and progress throughout the program.
- 4. <u>Be humanistic:</u> This classroom welcomes and supports all students, faculty, staff, and patients of all backgrounds and identities. Different people have different perspectives on issues, and that can be valuable for solving problems or generating new ideas. Being unable to understand why someone holds a viewpoint doesn't mean they are wrong. Don't forget that we all make mistakes, and blaming each other doesn't get us anywhere. There is a ZERO TOLERANCE for harassment or discrimination of any kind. Our differences can be our strengths, so let's celebrate them!
- 5. <u>Be socially and emotionally intelligent:</u> Self-reflect, be aware of one's own feelings in the present moment and communicate effectively with others while controlling impulses or reactive behavior.
- 6. <u>Be considerate:</u> We all depend on each other to create a safe and healthy learning environment. Your decisions will affect patients, other students, faculty, and staff (your colleagues), and you should take those considerations into account when making decisions and carefully choosing your words. *Don't make work for other people.*
- 7. <u>Be respectful</u>: We won't all agree all the time, but disagreement is no excuse for disrespectful behavior. An environment where people feel uncomfortable or threatened is not a productive or creative one. We will all experience frustration from time to time but we cannot allow that frustration to become personal attacks or bleed into our dental hygiene community here at TAMU.
- 8. <u>Be optimistic:</u> Teams with winning attitudes are known for their competitive spirit and energy as well as their pragmatic optimism. Practicing optimism involves training yourself to make positive assumptions about your current and future circumstances and success. It also involves modeling optimism and spreading positivity to others on your team. Team optimism may not happen overnight, but with time and practice, you can generate more positivity within yourself and across your team!
- Be professional and ethical: Comply with all program, college, and university policies. Take pride and uphold the Dental Hygiene Code of Ethics & Standards of Care by making a conscious effort to make sound ethical decisions that are based on the core values: Individual autonomy and respect for human beings, Confidentiality, Societal Trust, Non-maleficence, Beneficence, Justice and Fairness, and Veracity.

College and University Policies

Dental and Dental Hygiene Students – PHI Disciplinary Guidelines

Protected health information (PHI) is confidential and protected from access, use, or disclosure except to authorized individuals requiring access to such information. Attempting to obtain or use, actually obtaining or using, or assisting others to obtain or use PHI, when unauthorized or improper, will result in counseling and/or disciplinary action up to and including termination.

Definitions and Caveats

- PHI = Protected health information; this includes all forms of patient-related data including demographic information.
- Depending on the nature of the breach, violations at any level may result in more severe action or termination
- Levels I-III are considered to be without malicious intent; Level IV is considered malicious intent.
- At Levels II-IV, residents will be reported to the Texas State Board of Dental Examiners
- At Level IV, individuals may be subject to civil and/or criminal liability
- For any offense, a preliminary investigation will precede assignment of level of violation

Level IV	Releasing or using data for personal gain. Compiling a mailing list to be sold for personal gain or for some personal use. Disclosure or abusive use of PHI. Attendance Policy

The university views class attendance and participation as an individual student responsibility. Students are expected to attend class and to complete all assignments.
